





AGREEMENT TO ORDER OF PRESENTMENT


Pursuant to Practice Book § 2-82(g), the undersigned Respondent and Disciplinary Counsel stipulate and agree as follows:

1. This matter was instituted by grievance complaint filed by the Complainant, William Wright with the Statewide Grievance Committee on November 19, 2007.
2. On February 29, 2008, the local Grievance Panel for Ansonia/Milford found probable cause that the Respondent had violated Rules 8.1(2), 8.4(3) of the Rules of Professional Conduct and Practice Book § 2-32 (a)(1) arising from his failure to communicate with his client.
3. Respondent has been on interim suspension since June 21, 2007 pursuant to an order of the court, Alexander, J. in Docket No. CV-07-4013528, Disciplinary Counsel v. Gannon, in the Judicial District of Waterbury.
4. Respondent and Disciplinary Counsel and Respondent agree that an order of presentment may enter in the present matter.
5. Respondent and Disciplinary Counsel agree that pursuant to Practice Book § 2-82 (g) that this order of presentment is agreed to for the purpose of consolidating this matter with the matter currently pending before the court.

(g).


