





**AGREEMENT TO ORDER OF PRESENTMENT FOR CONSOLIDATION**

1. H. Jeffrey Beck (hereinafter Respondent), juris number 308959, was admitted to the bar of the State of Connecticut on December 8, 1988.
2. The Respondent has registered with the Statewide Grievance Committee for 2010 and is currently in good standing.
3. This matter was instituted by grievance complaint dated March 29, 2010.
4. On June 28, 2010, the Fairfield Judicial District Grievance Panel found probable cause that the Respondent had violated Rule 1.5(b) Fees; of the Rules of Professional Conduct.
5. The Respondent is already the subject of another disciplinary matter pending before the court, Disciplinary Counsel v. H. Jeffrey Beck, Docket No. 10-6011820-S, in the Judicial District of Fairfield at Bridgeport.
