



AGREEMENT TO ORDER OF PRESENTMENT FOR CONSOLIDATION


Pursuant to Practice Book § 2-82(g), the undersigned Respondent and Disciplinary Counsel stipulate and agree as follows:

1. John Blank (hereinafter Respondent), juris number 004810, was admitted to the bar of the State of Connecticut in October 1974.
2. The Respondent has registered with the Statewide Grievance Committee for 2011 and is currently under an order of interim suspension by the Bridgeport Superior Court, Honorable Barbara N. Bellis presided.
3. This matter was instituted by grievance complaint dated May 2, 2011.
4. On June 28, 2011, the Fairfield Judicial District Grievance Panel found probable cause that the Respondent violated Rules 1.15(e) and 8.1(2) of the Rules of Professional Conduct and Section 2-32(a)(1) of the Connecticut Practice Book
5. The Respondent is already the subject of another disciplinary matter pending before the court, Disciplinary Counsel v. John Blank, Docket No. FBT CV 11 6017729 S, in the Judicial District of Fairfield at Bridgeport.
6. The Respondent and the Disciplinary Counsel agree that an order of presentment may enter in the present matter.
7. Pursuant to Practice Book § 2-82(g), the Respondent and Disciplinary Counsel stipulate that the order of presentment is requested for the purpose of consolidating all pending disciplinary matters before the court.

WHEREFORE, this matter is submitted to the Statewide Grievance Committee for an order of presentment in accordance with Practice Book § 2-82(g).


