SUBJECT: Quarterly Report of the Client Security Fund Committee
January – March 2008

Pursuant to Practice Book §2-72(e), the following is a report of the activities of the Client Security Fund Committee for the first quarter of calendar year 2008:

I. Claims Filed

Twenty-three (23) claims for reimbursement were filed with the Client Security Fund Committee during the quarter, for an annual total as of the end of the quarter of twenty-three (23) claims, exclusive of one claim filed for an unspecified amount. The dollar amount of claims filed during the quarter was \$1,221,446.57, for an annual total of claims filed at the end of the quarter of \$1,221,446.57. The total number of claims pending before the committee as of the end of the quarter was one hundred and eleven (111), with a total amount of claims pending of \$5,364,310.60, exclusive of one claim filed for an unspecified amount.

II. Claims Approved

The Client Security Fund Committee approved reimbursement for twenty-six (26) claims during the quarter. The Committee approved payments to the claimants in those matters in the amount of \$520,525.21. The annual total of claims approved by the committee was twenty-six (26) as of the end of the quarter, with a total amount of payments approved of \$520,525.21.


The Committee also denied sixteen (16) claims totaling \$5,162,381.51 during the quarter, for an annual total of sixteen (16) claims denied in the amount of \$5,162,381.51.

III. Fund Activity

The client security fund received \$123,295.00 in collections from individuals obligated to pay the client security fund fee pursuant to Section §2-70 of the Practice Book during the quarter. The client security fund also received \$131,136.08 in interest on the fund, and \$13,630.29 in restitution from attorneys or former attorneys whose conduct resulted in payments from the fund.

After deductions for expenses, payments to claimants, and other charges against the fund, including \$50,645.37 paid to the Lawyers' Assistance Program pursuant to Practice Book Section 2-73(f), the available cash balance in the fund as of the end of the quarter was \$7,503,164.22. A copy of the quarterly reconciliation of the client security fund prepared by the Judicial Branch Fiscal Administration Unit is attached.
