SUBJECT: Annual Report of the Client Security Fund Committee

Pursuant to Practice Book §2-73(a), the following is a report of claims filed with the Client Security Fund Committee during calendar year 2018, and on the committee's activities during 2018 in connection with claims filed with the committee.

I. Claims Filed

During 2018, one hundred (100) claims for reimbursement were filed with the Client Security Fund Committee. By comparison, two hundred (200) claims were filed in 2017. The total dollar amount of claims for reimbursement filed with the fund during 2018 was \$7,361,590.87 as compared with \$7,538,231.56 in claims filed during 2017.

II. Activity on Claims

During 2018, the Client Security Fund Committee approved payments to claimants in one hundred and fifteen (115) claims filed with the committee. The total dollar amount of reimbursement approved during 2018 was \$3,040,493.64. By comparison, eighty-three (83) claims were approved for reimbursement during 2017, with a total amount of reimbursement approved of \$2,903,421.43. A list of the names of attorneys whose conduct resulted in awards of reimbursement during 2018, and the amounts awarded, is attached hereto. Seventy-two (72) claims were also denied during 2018.

At the end of calendar year 2018, one hundred and forty-two (142) claims remained pending in the total amount of \$12,694,793.64, as compared with two hundred and twenty-six (226) claims pending at the end of calendar year 2017 in the amount of \$12,733,974.86. The balance available in the client security fund at the end of 2018 was \$13,708,766.70.
