“1. Is the record adequate to review the petitioner’s claims of ineffective assistance of trial and habeas counsel when the habeas court had determined that its rejection of the petitioner’s claim under *Brady v. Maryland*, 373 U.S. 83, 83 S. Ct. 1194, 10 L. Ed. 2d 215 (1963), necessarily disposed of his ineffective assistance claims?”
