DEPUTY CHIEF STATE'S ATTORNEY FOR OPERATIONS

In addition, the Deputy Chief State's Attorney for Operations assists the State's Attorneys in investigations and prosecutions as needed.

The position requires significant experience in the prosecution of major crimes and the investigation of complex and sensitive matters. Experience in handling criminal appeals and other post-conviction litigation is strongly preferred. At the time of appointment, the successful candidate must be an attorney-at-law and shall have been admitted to the practice of law for at least three years; residency in the State of Connecticut is a prerequisite to appointment. The Deputy Chief State's Attorney for Operations shall devote his full time to the duties of his office and shall not otherwise engage in the practice of law and shall not be a partner, member or associate of a law firm.
