

Notice of Reinstatement with Probation

DOCKET NO. CV-13-6038797 S. DISCIPLINARY COUNSEL VS. DAVID C. KINNEY, SUPERIOR COURT, JUDICIAL DISTRICT OF NEW HAVEN, JUNE 12, 2018.

ORDER: As to the Respondent, David Kinney, juris number 303487, after full consideration by the Superior Court on his Application for Reinstatement at entry #117, it is hereby ORDERED: Respondent shall be reinstated to the practice of law with a two year probationary period, effective immediately and subject to the following conditions:

1. Each year, the Respondent must complete twenty hours of continuing legal education (“CLE”) courses to fulfill this order and his MCLE requirements for the years 2018 and 2019. Two courses each year must be in legal ethics. The Respondent must provide to the Office of Chief Disciplinary Counsel written confirmation of his attendance and compliance with this condition.
2. The Respondent shall utilize a mentor attorney for the two year probationary period. David Grudberg, Esq. of Carmody, Torrance, Sandak and Hennessey, a Connecticut Attorney in good standing, is appointed by the court as a mentor to the Respondent and must fulfill the following requirements along with providing advice and counsel:
 - a. The mentor must meet with the Respondent in person twice a month. The mentor must further communicate with the Respondent by email/ phone weekly;
 - b. The mentor must submit reports to the Office of Chief Disciplinary Counsel detailing the Respondent’s compliance with this condition, his compliance with all the conditions of this order and the overall status of the respondent/mentor relationship. In the first year of probation the reporting must be made quarterly. In the second year of probation the reporting must be done twice (at 6 months and within one month before the end of the probation term).
3. The Respondent must provide in writing, to the Office of Chief Disciplinary Counsel, language, consistent with the language read into the record in open court on June 12, 2108 and which shall be included in the firm retainer agreement, giving notice of his prior criminal prosecution, his suspension from practice and his reinstatement under this docket number.
4. The Respondent shall not have any access, signatory status or control over any IOLTA account. This condition remains in effect until such time as the Respondent retires from the practice of law pursuant to Practice Book 2-55 or 2-55A.
5. The Respondent is to be employed at the Law offices of Timothy Gunning or its successor and provide the Office of Chief Disciplinary Counsel with proof of that employment and notice of any changes to the status. The Respondent may practice law only if he is employed by a firm or a member of a firm.
6. The Respondent must have the benefit of malpractice insurance coverage until such time as he retires from the practice of law. The Respondent shall provide proof of coverage in writing to the Office of Chief Disciplinary Counsel at the onset of the probationary period and each year during the probation term.

7. The Respondent shall limit his practice to personal injury and workers compensation matters. The respondent may represent past or present personal injury and workers compensation clients in Part B criminal matters only.
8. The Respondent acknowledges that he has certain outstanding court and tax obligations and he shall continue to educate himself about their status. The respondent shall make and pursue a plan to comply with all of his outstanding financial obligations. He shall advise the Office of Chief Disciplinary Counsel of that plan and compliance. Failure to make payments on any court or tax obligations without good cause may result in the filing of new grievance complaints by the Office of Chief Disciplinary Counsel.
9. The Court retains jurisdiction over the monitoring of the Respondent and his compliance with these conditions during the probationary term. The respondent, through counsel, shall submit a summary to the court of his compliance with these conditions at the expiration of the first year of probation. The court will review the compliance to determine if any additional conditions should be imposed.
10. All of the foregoing conditions will remain in effect until further order of the Court.
11. The probationary period will expire two years from the effective date of this order absent any action or motion by the Office of Chief Disciplinary Counsel. Absent such action or motion, the New Haven upon the expiration of the probationary period.
