ORDER

The following order is entered in the above matter:

After two days of hearings in this matter during which testimony was presented and documents were entered into evidence, the court enters the following orders for reasons state on the record:

1. It is hereby ordered that the respondent be suspended from the practice of law for an interim period while an audit of her IOTA account from January 1, 2016 to the present day is conducted.
2. Attorney Bonnie Mangan, Juris No. 309469, is hereby appointed as trustee pursuant to Practice Book 2-64 to oversee the respondent's account to protect the interests of her clients and assist in the audit.
3. The respondent shall not deposit or withdraw funds from her IOTA account during the period of her suspension.
4. The respondent shall comply with the dictates of Practice Book 2-47B regarding the activities of deactivated attorneys.
5. The respondent shall retain a bookkeeper to assist in the completion of the audit.
6. The court shall hold a status conference in this matter on September 27, 2018 at 2:00 p.m. to ascertain the status of the audit. The court will hold a status conference should the parties mutually request one.
7. The court reserves any further disciplinary action in this matter until the completion of the audit.
