NOTICE OF SUSPENSION OF ATTORNEY

Pursuant to Practice Book § 2-54, notice is hereby given that on August 28, 2018, Attorney Robert Heroux, Juris #425905, was ordered suspended from the practice of law by the Hon. Irene Jacobs for a period of 30 days.

Notice of Discipline

Pursuant to § 2-54 of the Connecticut Practice Book, notice is hereby given that on August 23, 2018, in Docket Number HHD-CV-17-6084134 Musa Sebadduka, juris # 425881, stipulated as follows:

1. The interim suspension imposed by the Court on January 2, 2018 shall be terminated and the Respondent shall be reinstated, subject to the order of suspension dated June 4, 2018 on the Second Count of the Amended Presentment of Attorney for Misconduct dated April 5, 2018.
2. The Respondent, having previously been found to have violated Rule 8.1 (2) of the Rules of Professional Conduct and § 2-27 of the Connecticut Practice Book, shall be reprimanded.
3. The Respondent shall create and maintain IOLTA account records that are in compliance with Rule 1.15(j) of the Rules of Professional Conduct.
4. The Respondent shall engage the services of a bookkeeper or accountant on or before October 8, 2018. If on or about October 9, 2019, the bookkeeper or accountant certifies to Disciplinary Counsel that the Respondent is able to properly maintain his own IOLTA account records, the services of the bookkeeper or accountant may be terminated. If the bookkeeper or accountant is unable to make such certification, the Respondent shall continue to engage the services of the bookkeeper or accountant until such time as the bookkeeper or accountant is able to make a certification to Disciplinary Counsel.
5. The Respondent shall submit to, and fully cooperate with, monthly audits of his clients' funds account by the Statewide Grievance Committee for the period beginning October 1, 2018 through and including September 30, 2019. The Respondent and the Disciplinary Counsel agree that if any issues are discovered, any additional audit period may be determined at the discretion of the Statewide Grievance Committee. Otherwise, if no issues are discovered, the audits will cease after the period including September 30, 2019.

Notice of Suspension of Attorney

Pursuant to § 2-54 of the Connecticut Practice Book, notice is hereby given that on August 30, 2018 in Docket Number HHD-CV-18-6097916-S John Paul Carroll, juris # 417951 of Naperville, IL was suspended from the practice of law for a period of six months, commencing June 14, 2018.
