### Notice of Suspension of Attorney

---

Pursuant to Practice Book § 2-54, notice is hereby given that on 01/02/2019 in docket number MMXCV17-6018377S, Gerald M. Beaudoin, juris number #402116 of Broad Brook, CT was suspended from the practice of law, with the following conditions:

For the foregoing reasons, the court enters the following attorney discipline:

- (1) The respondent shall be suspended from the practice of law for a period of eighteen months retroactive to August 29, 2017.
- (2) The respondent shall be reinstated to the practice of law in the state of Connecticut on March 1, 2019.
- (3) Pursuant to Practice Book § 2-53 (d), no further reinstatement application will be required.
- (4) The respondent shall be subject to a two year probationary period, subject to the following conditions:
  - a. The respondent must attend two courses each year on legal ethics.
  - b. The respondent shall not practice alone for the two year probationary period.
  - c. The respondent shall utilize a mentor attorney for the two year probationary period.
  - d. The respondent and the mentor shall meet in person at least once a month. The respondent shall further communicate with the mentor weekly by e-mail or phone.
  - e. The respondent shall not have any access, signatory status or control over any IOLTA accounts during the probationary period.
  - f. The respondent shall have the benefit of malpractice insurance coverage until such time as he retires from the practice of law.
  - g. The court retains jurisdiction over the monitoring of the respondent and his compliance with these conditions during the probationary term. The respondent, through counsel, shall submit a summary to the court of his compliance with these conditions at the expiration of the first year of probation and the expiration of the second year of probation. The court will review compliance to determine if any additional conditions should be imposed.
  - h. The probationary period will expire on March 1, 2021, absent any action or motion by the Office of Chief Disciplinary Counsel.

ORDER: The Respondent, Keisha Gatison, is hereby suspended from the practice of law for a period of one year, effective January 22, 2019.

Pursuant to Practice Book 2-64, Attorney Edward Giacci, Juris #401592, is appointed Trustee to take such steps as are necessary to protect the interest of the Respondent's clients, to inventory her files, and to take control of all of her clients' funds, IOLTA and fiduciary bank accounts. The Respondent is hereby ordered to fully cooperate with the Trustee in this regard. The Respondent shall comply with the requirements contained in Practice Book 2-47B entitled "Restrictions on the Activities of Deactivated Attorneys". The Respondent shall file an application with the Connecticut Bar Association program regarding the resolution of fee disputes on or before March 1, 2019, seeking binding arbitration involving Grievance Decision No. 18-30 and will make reasonable efforts to promptly resolve all outstanding issues related to this matter.

The Respondent shall provide restitution in the amount of \$1950.00 to the claimant

In Grievance Complaint No. 18-0307 prior to seeking reinstatement. At conclusion of her suspension, the Respondent may apply for reinstatement pursuant to the requirements contained in Practice Book 2-53.
