Operating motor vehicle while under influence of intoxicating liquor or drugs in violation of applicable statute (§ 14-227a); whether enhanced penalty for operation while under influence pursuant to § 14-227a (g) applicable; claim that conviction under Florida statute for operating motor vehicle while under influence did not qualify as prior conviction for same offense under § 14-227a (a); claim that application of current revision of § 14-227a violated ex post facto clause; claim that elements of Florida statute and § 14-227a (a) were not substantially similar; claim that State v. Burns (236 Conn. 18) and State v. Mattioli (210 Conn. 573) should be overruled on the basis that they contravene plain language of § 14-227a (g).

Breach of contract; whether trial court properly rendered judgment for plaintiff employer on its claim for breach of contract; whether trial court properly granted plaintiff's motion for attorney's fees; adoption of trial court's memoranda of decision as proper statements of facts and applicable law.
