<i>Negligence; appeal from finding by defendant state board of veterinary medicine that plaintiff was negligent pursuant to statute (§ 20-202 (2)); whether plain reading of statute (§ 22-359b) and regulation (§ 22-359-1) yielded absurd or unworkable result; reviewability of claim that trial court erred in concluding that substantial evidence supported board's finding that plaintiff had failed to receive informed consent from his client; reviewability of claim that trial court erred in concluding that board did not exceed its authority or abuse its discretion in imposing disciplinary order on plaintiff; failure to brief claim adequately.</i>
