<i>Termination of parental rights; whether trial court properly admitted summaries from Department of Children and Families' service provider under business records exception to hearsay rule codified in provision (§ 8-4 (a)) of Connecticut Code of Evidence; claim that trial court improperly concluded that respondent mother was unable or unwilling to benefit from reunification services provided to her by department pursuant to statute (§ 17a-112).</i>

<i>Motion to correct illegal sentence; motion to dismiss; whether trial court erred in granting state's motion to dismiss defendant's motion to correct illegal sentence because it considered merits of defendant's claims instead of determining whether he had made colorable claim that his sentence was illegal or imposed in illegal manner; whether remand for consideration of merits of defendant's claims would serve useful purpose because defendant's claims failed as matter of law; claim that statutory provisions (§§ 54-91g and 54-125a (f)) requiring consideration of youth as mitigating factor and pertaining to parole eligibility for juvenile offenders violated twenty year old defendant's rights to equal protection because those provisions do not apply to defendants who were over eighteen years of age but under twenty-one years of age at time of offense.</i>

<i>Violation of probation; probation revocation hearing; claim that admission of hearsay statements at probation revocation hearing violated defendant's due process right to cross-examination; claim that trial court improperly failed to conduct balancing test pursuant to State v. Shakir (130 Conn. App. 458) to determine whether good cause existed for defendant's inability to confront and cross-examine witness at probation revocation hearing concerning admitted hearsay statements; claim that hearsay statements should have been excluded on evidentiary grounds; whether hearsay statements were reliable and corroborated.</i>

<i>Habeas corpus; whether habeas court abused its discretion in denying petition for certification to appeal; claim that petitioner was deprived of due process right to fair trial because appellate counsel and first habeas counsel rendered ineffective</i>
