Notice of Suspension of Attorney

Pursuant to Practice Book Section §2-54, notice is hereby given that on April 1, 2024, in Docket Number HHD-CV-23-6176458-S, Karen Stolp Poirier, Juris No. 430090 of Manchester, CT is placed on suspension from the practice of law in Connecticut for a period of one-year, effective April 1, 2024.
